Alternate Water Source

An additional eighty-seven cents (\$0.87) per one thousand (1,000) gallons of water consumed per month. The revenues from these charges are restricted to defray expenses of the city associated with obtaining alternative water sources in order to comply with the groundwater laws of the State.

Construction/Hydrant Meter billed \$3.87 per 1,000 gallons.
