Alternate Water Source

An additional eighty-nine cents (\$0.89) per one thousand (1,000) gallons of water consumed per month. The revenues from these charges are restricted to defray expenses of the city associated with obtaining alternative water sources in order to comply with the groundwater laws of the State.

Construction/Hydrant Meter billed \$3.87 per 1,000 gallons.

Rates for Customers in the Town of Chino Valley

Add thirty per cent (30%) to the above rates.

Rates for Customers Outside City or Town Limits

Add per cent (40%) to the above rates.

Tax on Water

All water sales are subject to privilege tax of 8.35% (6.35% State of Arizona, .75% Yavapai County, and 2% City of Prescott)

In addition to privilege tax the State of Arizona imposes a tax of \$.65 per 1,000 gallons of water per ARS 42-5302
